Sustainable Development Concept and Challenges in Nigeria

This regional variance calls for localized adaptations of EE programs, but such adaptations are often lacking due to a lack of policy integration and coordination among stakeholders (Ayoade, 2011).

While formal education plays a foundational role, the potential of informal and non-formal environmental education should not be overlooked. Informal education methods, including community-based initiatives, media campaigns, and environmental advocacy groups, are essential in reaching wider audiences, especially in rural areas where formal schooling may be less accessible. The involvement of Non-Governmental Organizations (NGOs) such as the Nigerian Conservation Foundation (NCF) and Environmental Rights Action (ERA) has contributed significantly to raising environmental awareness among marginalized groups and providing practical solutions to local environmental problems (Agwu & Soyewo, 2015).
