#### **Abstract**

This paper investigated entrepreneurship skills acquisition and economic empowerment of students in public universities in Rivers State. As unemployment rates continue to rise in Nigeria, higher education institutions have resorted to equipping students with practical skills necessary for business creation and self-reliance. This paper discussed various entrepreneurship skills imparted through university programmes, including business management, financial literacy, creativity, and problem-solving. Stantcheva (2021) builds upon this foundational theory by examining how public policies, particularly taxation, influence investments in human capital and social mobility, emphasizing the importance of supportive governmental frameworks in ensuring equitable access to education and skill development.

Human Capital Theory serves as a relevant framework for understanding how equipping students with entrepreneurial skills enhances their ability to create economic opportunities. Students who acquire financial literacy skills understand the principles of bookkeeping, cost control, and financial forecasting, all of which are critical for making informed business decisions. Additionally, financial literacy enhances the ability to secure funding from investors, financial institutions, or government grants. Mastering these skills ensures that students can manage business capital efficiently, avoid financial mismanagement, and achieve long-term profitability.

#### Marketing and Sales Skills

Marketing and sales skills are essential for business growth, customer acquisition, and long-term profitability. Marketing involves identifying customer needs, segmenting target markets, and promoting products or services through strategies such as branding, digital advertising, and content creation (Kotler & Keller, 2016). Key skills include market research, customer

segmentation, and digital marketing proficiency. Sales, on the other hand, focuses on converting prospects into paying customers through persuasion, relationship-building, and effective communication. Essential sales skills include prospecting, product knowledge, negotiation, and closing techniques (Rackham, 1988). The integration of both functions known as 'smarketing' ensures alignment between marketing strategies and sales execution, improving overall performance and customer satisfaction (Kotler et al., 2006). In today's competitive environment, professionals and entrepreneurs must develop strong marketing and sales capabilities to drive engagement, generate revenue, and sustain competitive advantage.

# Innovation and Creativity Skills

Innovation and creativity skills enable students to develop unique business ideas and create competitive advantages in their industries. Creativity allows entrepreneurs to design new products, improve existing services, and find solutions to business challenges. According to Adeyemi and Okeke (2023), businesses that thrive in competitive markets rely on innovative ideas and continuous improvement to maintain customer interest. Students who cultivate innovative thinking can identify unmet market needs and introduce groundbreaking solutions that enhance business profitability. Additionally, creativity fosters adaptability, enabling entrepreneurs to navigate economic uncertainties and technological advancements. Businesses that prioritize innovation often experience long-term sustainability and improved market positioning. Therefore, acquiring creative skills is essential for students who seek to establish dynamic and resilient enterprises.

# Problem-Solving and Decision-Making Skills

Moreover, strong communication skills help students build brand credibility and customer trust, leading to increased business opportunities. Entrepreneurs who excel in networking can access mentorship programmes, funding opportunities, and industry

insights that contribute to business success. These skills are particularly crucial in expanding business ventures and securing long-term sustainability.

# Adaptability and Resilience Skills

Entrepreneurs often face uncertainties such as financial instability, changing consumer trends, and technological advancements. Nwachukwu and Ojo (2023) emphasized that students who develop resilience are better prepared to handle setbacks, maintain business continuity, and seek alternative solutions to challenges. Adaptability allows entrepreneurs to modify business strategies in response to emerging trends and customer demands. Entrepreneurs who possess resilience can recover from financial losses, rebrand their businesses, and explore new market opportunities. These skills ensure long-term business survival and personal growth, making them vital for students who aspire to become successful entrepreneurs.

# CHALLENGES OF ENTREPRENEURSHIP SKILLS ACQUISITION IN PUBLIC UNIVERSITIES

Entrepreneurship skills acquisition in public universities plays a crucial role in equipping students with the knowledge and competencies needed for self-employment and economic empowerment. However, various challenges hinder the effectiveness of entrepreneurship education in Nigerian public universities. These challenges affect students' ability to develop the required skills, thereby limiting their entrepreneurial potential. The following are some of the major challenges associated with entrepreneurship skills acquisition in public universities.

#### Inadequate Funding

Limited financial resources remain a major barrier to effective entrepreneurship education in public universities. Furthermore, inadequate funding affects the quality of teaching staff and the provision of essential materials. Without proper financial backing, universities may find it difficult to organize workshops, seminars, and business mentorship programmes that enhance entrepreneurship skills acquisition. This financial limitation ultimately affects the employability and self-reliance of graduates.

#### Lack of Practical Exposure

Entrepreneurship education in many public universities is often theoretical, with little emphasis on practical application. The lack of real-world business exposure prevents students from gaining the hands-on experience needed to develop entrepreneurial competencies. Eze and Udoh (2023) noted that many Nigerian universities still rely on outdated teaching methods that focus more on

lectures and textbooks rather than experiential learning. Practical training, such as business simulations, startup incubators, and internships, is crucial in equipping students with relevant entrepreneurship skills. However, most universities lack partnerships with industries and financial institutions that could provide students with opportunities for real-world business engagement. As a result, students graduate with limited entrepreneurial experience, making it difficult for them to establish and sustain businesses.

# Shortage of Qualified Entrepreneurship Educators

The effectiveness of entrepreneurship education largely depends on the quality of instructors delivering the training. Many Nigerian public universities face a shortage of lecturers who have practical business experience. According to Anene and Uchenna (2023), most entrepreneurship lecturers possess academic qualifications but lack firsthand experience in business startups, investment, and risk management. This knowledge gap reduces the effectiveness of entrepreneurship education, as students struggle to acquire skills that can only be learned through practical engagement. Moreover, some universities assign entrepreneurship courses to lecturers from unrelated disciplines, leading to ineffective knowledge transfer. Without exposure to business operations, educators may find it challenging to teach students real-world business strategies and skills, thereby limiting their entrepreneurial development.

# Limited Access to Start-Up Capital

Access to startup capital is one of the biggest challenges faced by students aspiring to become entrepreneurs. Public universities often do not provide financial support or credit facilities to students who wish to start businesses. According to Anene and Uchenna (2023), lack of access to funding discourages students from applying their entrepreneurship skills, as they are unable to turn their business ideas into reality. Although some financial institutions and government agencies offer loans and grants to young entrepreneurs, many students lack awareness of these funding opportunities. In addition, stringent loan requirements and high interest rates make it difficult for students to secure the necessary capital to launch their businesses. The absence of financial support limits the practical implementation of entrepreneurship skills, resulting in a low success rate of student-led startups.

#### **Outdated Curriculum and Teaching Methods**

The entrepreneurship curriculum in many Nigerian public universities has not been updated to reflect modern business trends and technological advancements. According to Nwachukwu and Ojo (2023), many universities still rely on traditional business theories that do not address contemporary challenges such as digital entrepreneurship, e-commerce, and technological innovations. This outdated curriculum limits students' ability to adapt to the evolving business environment. Additionally, the teaching methods used in many universities do not encourage innovation and creativity. Entrepreneurship education should involve interactive sessions, case studies, business simulations, and mentorship programmes. However, the current instructional methods remain largely theoretical, preventing students from developing practical problem-solving skills needed in business.

# Poor Infrastructure and Learning Facilities

Entrepreneurship education requires well-equipped training centers, business incubation hubs, and access to digital tools. However, most public universities in Nigeria lack the necessary infrastructure to support effective entrepreneurship training. Inadequate access to modern technology, internet connectivity, and workspace facilities limits students' ability to acquire relevant business skills. Entrepreneurship skills acquisition also requires well-equipped laboratories where students can practice product development, manufacturing processes, and innovation techniques. However, most universities do not have functional business incubation centers where students can test and refine their business ideas before launching them. Without the right infrastructure, students struggle to translate theoretical knowledge into practical business ventures.

#### Socio-Cultural and Psychological Barriers

Cultural beliefs and societal perceptions about entrepreneurship pose a major challenge to skills acquisition in public universities. Many students are influenced by the societal preference for white-collar jobs, leading to a lack of motivation for entrepreneurship. According to Nwachukwu (2020), some students view entrepreneurship as a last resort rather than a viable career path. This mindset discourages students from actively engaging in entrepreneurship training and skill acquisition. Additionally, fear of business failure prevents many students from taking entrepreneurial risks. Entrepreneurship involves uncertainties, and without the right mentorship and encouragement, students may be reluctant to pursue business ventures. The absence of an entrepreneurial mindset hinders the effectiveness of entrepreneurship education, making it difficult for students to fully engage in skill acquisition.

#### Lack of Government and Institutional Support

Government policies and institutional support play a crucial role in entrepreneurship skills acquisition. However, many public universities lack structured entrepreneurship development programmes due to poor government intervention. According to Chinwe and Nwosu (2020), government agencies responsible for entrepreneurship development often fail to provide the necessary resources, mentorship programmes, and funding for student entrepreneurs. Additionally, universities do not have well-defined policies for integrating entrepreneurship training into the academic curriculum. Many students are not encouraged to participate in entrepreneurial activities due to the absence of clear institutional frameworks. Without adequate support from government agencies and educational institutions, entrepreneurship education in public universities remains underdeveloped.

#### Strategies for Entrepreneurship Skills Development in Universities

Entrepreneurship skills development in universities is essential for equipping students with the knowledge, competencies, and mindset required to create and manage successful business ventures. Effective strategies must be implemented to enhance students' entrepreneurial

capabilities, improve self-reliance, and contribute to economic development. The following strategies can strengthen entrepreneurship skills acquisition in universities.

# Integration of Practical Entrepreneurship Training into the Curriculum

Entrepreneurship education should go beyond theoretical learning and emphasize practical business experience. Universities need to integrate hands-on training, business simulations, and real-world projects into the curriculum to enhance students' entrepreneurial skills. According to Okonkwo and Amadi (2021), practical exposure enables students to develop problem-solving abilities, risk management strategies, and innovation skills necessary for business success. Moreover, universities should ensure that entrepreneurship courses involve project-based learning, where students create business plans, develop prototypes, and engage in entrepreneurial ventures before graduation. This approach allows students to apply theoretical knowledge to real-life business challenges.

#### Establishment of Business Incubation Centers

The creation of business incubation centers within universities can provide students with access to mentorship, resources, and funding opportunities. Business incubators help students refine their business ideas, develop products, and test their entrepreneurial ventures in a controlled environment. Incubators play a crucial role in supporting startups by providing workspace, networking opportunities, and advisory services. Additionally, incubation centers can facilitate collaboration between students and experienced entrepreneurs, allowing knowledge transfer and mentorship. Through these centers, students can receive guidance on business development, marketing strategies, and financial management, which are essential for entrepreneurship success.

#### Strengthening Industry and University Partnerships

Collaboration between universities and industries enhances entrepreneurship education by exposing students to real-world business environments. Universities should establish strong partnerships with business organizations, financial institutions, and government agencies to create internship opportunities, training programmes, and entrepreneurial mentorship. Furthermore, universities can invite industry experts as guest lecturers, organize entrepreneurship summits, and facilitate networking events where students can interact with successful entrepreneurs. These engagements provide students with valuable knowledge on how to navigate business challenges and explore innovative opportunities.

# Provision of Start-Up Capital and Financial Support

Access to funding is one of the major barriers to entrepreneurship among university students. Universities should create funding opportunities such as grants, low-interest loans, and business competitions to support student-led startups. According to Eze and Udoh (2023), financial support enables students to transform business ideas into viable enterprises, thereby promoting

self-employment and economic growth. Additionally, universities can collaborate with government agencies, private investors, and non-governmental organizations to establish entrepreneurship funding schemes. Providing students with access to capital encourages them to take entrepreneurial risks and develop sustainable business ventures.

# Adoption of Digital and Technological Innovations

Entrepreneurship education must incorporate digital skills and technological advancements to prepare students for modern business challenges. Universities should integrate courses on digital marketing, e-commerce, financial technology, and business automation into entrepreneurship training programmes. According to Nwachukwu and Ojo (2023), digital entrepreneurship has become a key driver of economic growth, and students must be equipped with skills to leverage technology for business success. Moreover, universities should provide access to digital tools, software, and online business platforms to help students develop digital business models. Exposure to technology-driven entrepreneurship enhances students' competitiveness in both local and global markets.

# Capacity Building for Entrepreneurship Educators

The effectiveness of entrepreneurship education depends on the quality of instructors delivering the training. Universities should invest in the continuous training and development of entrepreneurship educators to ensure they possess both theoretical and practical business knowledge. According to Okafor and Eze (2022), many entrepreneurship lecturers in Nigerian universities lack real-world business experience, limiting their ability to effectively train students. Furthermore, universities should encourage lecturers to participate in business development programmes, entrepreneurial research, and industry engagement. When educators have practical knowledge of entrepreneurship, they can effectively mentor students and provide valuable insights into business success strategies.

#### Encouragement of Student-Led Entrepreneurial Activities

Universities should create platforms for students to engage in entrepreneurial activities through business clubs, innovation hubs, and startup competitions. Organizing entrepreneurship boot camps, hackathons, and business pitch events enables students to showcase their business ideas and receive constructive feedback from experts. Student-led entrepreneurial initiatives foster creativity, teamwork, and problem-solving skills. Additionally, universities can support student-run businesses by providing access to campus markets, product development resources, and promotional platforms. Creating a business-friendly environment within universities encourages students to take entrepreneurship seriously and gain real-world business experience.

#### Policy Development and Institutional Support

Government policies and university regulations play a crucial role in promoting entrepreneurship education. Universities should develop clear policies that mandate entrepreneurship training for all students, regardless of their field of study. According to Nwachukwu and Ojo (2023), incorporating entrepreneurship as a core course ensures that students develop business

competencies alongside their academic programmes. Furthermore, government agencies should implement policies that provide financial incentives, tax reliefs, and business grants for student entrepreneurs. Creating a supportive regulatory framework for entrepreneurship education enhances students' ability to start and sustain businesses.

# Promotion of Entrepreneurial Mindset and Risk-Taking Culture

Developing an entrepreneurial mindset among students requires exposure to business case studies, success stories, and real-life challenges. Universities should encourage students to embrace creativity, innovation, and calculated risk-taking. Entrepreneurial success depends on resilience, adaptability, and the ability to seize business opportunities. Additionally, universities can implement mentorship programmes where successful entrepreneurs share their experiences, challenges, and business strategies with students. Encouraging students to adopt a proactive and problem-solving approach to entrepreneurship increases their confidence and willingness to explore business opportunities.

#### **CONCLUSION**

Entrepreneurship skills acquisition plays a vital role in fostering the economic empowerment of students in public universities in Rivers State. As unemployment continues to pose challenges in Nigeria, the need for self-reliance through entrepreneurship has become more pronounced. Public universities serve as key institutions in equipping students with essential business management, financial literacy, innovation, and problem-solving skills necessary for establishing and sustaining entrepreneurial ventures. #### **Suggestions**

To enhance entrepreneurship skills acquisition and economic empowerment of students in public universities in Rivers State, key stakeholders must take proactive measures to create a supportive learning and business environment. The following suggestions outlined the roles of various stakeholders in strengthening entrepreneurship education:

- Ministry of Education should develop and enforce policies that integrate practical entrepreneurship training into university curricula, ensuring that students gain hands-on experience alongside theoretical knowledge.
- Policy Makers should formulate and implement policies that create a conducive environment for student entrepreneurs, including tax incentives for student-led start-ups and simplified business registration processes.

- Government Agencies should collaborate with public universities to provide funding, infrastructure, and other resources that enhance entrepreneurship education and training.
- School Administrators should incorporate entrepreneurship training into various academic programmes, ensuring that students from all disciplines gain exposure to business skills.
